During our 21/22 fiscal year through a network of 35 food pantries, including a grocery home delivery program, nutritious food was distributed to 98,676 people in our community in need. Through our Meals on Wheels program, healthy prepared meals were delivered to 330 recipients who live in their own homes but are infirm and cannot prepare meals for themselves as well as to three adult/child daycares.
